RESOLUTION NO. 2021-09**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE PORT OF LONGVIEW FILING THE FINAL BUDGET AND SUBMITTING A REQUEST FOR TAX LEVIES FOR CALENDAR YEAR 2022 WITH THE CLERK OF THE BOARD OF COWLITZ COUNTY COMMISSIONERS.**

**WHEREAS**, the Board of Commissioners of the Port of Longview, by Resolution 2021-07 dated November 23, 2021, approved and adopted the Final Budget for calendar year 2022, it was ordered and directed there be a tax levy upon all of the property within the Port of Longview District for capital projects and the payment of interest and redemption of limited tax general obligation bonds of the Port of Longview in the sum of ***one million, five hundred nineteen thousand, six hundred and no cents (\$1,519,600)***. The total tax levy rate for collection in 2022 is ***\$.127527*** per \$1,000 of assessed valuation.

**IT IS ORDERED AND DIRECTED** that the County Treasurer place all property tax receipts into the Port's Property Tax Fund.




