**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE  
PORT OF LONGVIEW ESTABLISHING A COMMISSION MEETING  
SCHEDULE FOR 2026.**

**WHEREAS**, the Board of Commissioners ("Commission") of the Port of Longview ("Port") adopted Resolution No. 2025-01 which establishes rules governing the Commission's transaction of Port Board business; and

**WHEREAS**, Article IV of Resolution No. 2025-01 provides in part that the Commission will establish a Regular Meeting Schedule during the last meeting of each calendar year; and

**WHEREAS**, the Commission desires to meet the intent of Resolution 2025-01 by establishing a Regular Meeting Schedule for January through December, 2026.

**NOW THEREFORE, BE IT RESOLVED** that the Commission adopts the following Regular Meeting Schedule for the period of January through December 2026, effective as of January 1, 2026, and establishing that the Board of Commissioners of the Port of Longview will hold its Regular Commission meetings at 9:00 AM on the second and fourth Wednesdays of each month, at the Port Office located at 10 International Way in Longview, Washington, except as noted below. Budget Work Sessions will be noted as a Special Meeting and will commence at 9:00 AM at the Port Offices, which shall be confirmed through publication and distribution of individual meeting notices, and are also subject to change consistent with the requirements of the Open Public Meetings Act.
